GOAL 11: Sustainable Cites and Communities


Social license and long term impact

There was unprecedented international attention on IMARC this year, with protestors and ensuing media putting a spotlight on the industry as a whole.

The theme of 'social license to operate' occupied the programme on day two with various sessions focused on issues that align to the SDGs overall. With this level of focus, there was great consensus that the adoption of sustainable practices will become increasingly crucial to the long-term success in of the industry.

Key issues facing Boards & Executive:

- Rising expectations of investors, customers, stakeholders
- Boards expected to provide ESG oversight & governance
- Tell the sustainability story or else someone else will
- Increasing pressure for appropriate disclosures
- Pressure to be able to measure and report on performance
- Director liabilities and penalties for poor governance over environmental matters e.g. climate risk disclosure
- Multiple emerging sustainability risks and liability scenarios.
